Sehubungan itu, maklum balas daripada pihak industri serta *Federation of Malaysian Manufacturers (FMM) Malaysian Food Manufacturing Group (MAFMAG)* berhubung pelaksanaan kriteria nutrien baharu telah diteliti dan seterusnya dimuktamadkan serta dibentangkan dalam sesi taklimat yang telah diadakan pada 29 Julai 2021.

3. Untuk makluman YBhg. Datuk/ Dato'/ Tuan/ Puan, kriteria nutrien HCL baharu ini merangkumi penetapan kriteria bagi kategori produk baharu serta semakan semula kriteria nutrien yang sedia ada.
